2. HAZARDS IDENTIFICATION

Main hazards: Harmful by inhalation. Irritating to eyes, respiratory system and skin. May cause sensitisation by

inhalation.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be irritation and redness. The eyes may water profusely.

Ingestion: There may be soreness and redness of the mouth and throat. Nausea and stomach pain may

occur. There may be vomiting.

Inhalation: There may be irritation of the throat with a feeling of tightness in the chest.

4. FIRST AID MEASURES (ACTION)

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the

affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a

doctor.

5. FIRE-FIGHTING MEASURES

Extinguishing media: Alcohol or polymer foam. Carbon dioxide. Dry chemical powder. Use water spray to cool

containers.

Exposure hazards: In combustion emits toxic fumes.

Protection of fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin

and eyes.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Refer to section 8 of SDS for personal protection details. If outside do not approach from

downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking

containers leak-side up to prevent the escape of liquid.

Clean-up procedures: Clean-up should be dealt with only by qualified personnel familiar with the specific substance.

Allow product to solidify and remove it by mechanical means. Remove uncured foam with acetone Transfer to a closable, labelled salvage container for disposal by an appropriate

method.

7. HANDLING AND STORAGE

Handling requirements: Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do

not handle in a confined space. Avoid the formation or spread of mists in the air.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. Store in original containers

between +5 and +25°C. Storage outside these paramaters will dramatically reduce shelf life and

invalidates all product warrenties.

Suitable packaging: Must only be kept in original packaging.
