APPLICATION

ALWAYS TEST PAINTED OR COATED SURFACES/PLASTICS FOR COMPATIBILITY PRIOR TO FULL APPLICATION. Shake the can and spray directly and liberally onto affected area. Allow time to penetrate (two minutes to 1 hour depending on type of stain) then wipe away graffiti and rinse area with water. For stubborn stains, dry area and repeat process.

CAUTION

Pressurised container. Protect from sunlight and do not expose to temperatures exceeding 50 °C. Do not pierce or burn even after use. Do not spray on a naked flame or incandescent material.
